When walking and or riding, please avoid freshly watered areas, and at all times do what is necessary to avoid impact to the fields. All dog debris must be disposed of accordingly, there are dumpsters near the clubhouse.

We ask you to observe all signs with walking and riding information and to be mindful and courteous of any public or private activities that may be occurring at the facility during your visit. Saturday afternoons and evenings, especially during wedding season and Sundays during polo season must be limited due to events held on the field and at the clubhouse. You may be asked to reschedule your visit if it is during a scheduled activity.
