2025 Member Riding/Walking Release of Liability

Riding and walking privileges at the BHEC are for paid Patrons exclusively and require a signed release and appropriate horse health documentation.

These privileges are intended for Patrons and their immediate family.

BHEC is available for Patron walking/riding, May 15-September 30, 2025

When walking/riding, please be weather aware and avoid BHEC field closings and freshly watered/sprinkler restricted areas. At all times do what is necessary to avoid any impact to the fields. The Clubhouse/yard is not an area for public or patron use other than during predetermined events.

All dogs must be leashed at all times and dog debris must be disposed of immediately, there are dumpsters near the clubhouse. Due to the nature of BHEC events, we request you do not allow pets or children to be near the clubhouse or yard at any time, this includes the lawn area that has a wooden fence perimeter.

We ask you to observe all signage and to be mindful and courteous of any public or private activities that may be occurring at the facility during your visit. Park in areas away from the clubhouse area.

Saturdays and evenings, especially during wedding season and Polo scheduled events, walking and riding must be limited due to events held on the field and at the clubhouse. You may be asked to reschedule your visit if it is during a scheduled activity.
